Documentary proof of release from service or official military orders are required. On the first day a vote center opens (Fresno and Kings counties) or before the day of the election (Kern and Tulare counties), the county elections official shall deliver to the precinct board a list of military or overseas voters registered under Elections Code section 3108.</p> <p>A military or overseas voter or any individual born outside of the United States or District of Columbia whose parent or legal guardian was a resident of California when the parent was last living in the United States who returns to the county after May 14, 2024 (E-7), may appear before the county elections official and apply for registration, a vote-by-mail ballot, or both. * Elections Code section 3114 and the federal MOVE Act require that ballots and ballot materials be transmitted to each military and overseas voter no later than 45 days prior to an election. E-45 is April 6, 2024, which is a Saturday; this deadline must be adhered to and does not move forward to the next business day.

** Date falls on a weekend or state holiday; it moves forward to the next business day.
