Declarations of Candidacy for eligible candidates desiring to file may be obtained from the Elections Division, 1115 Truxtun Avenue, Bakersfield, commencing on July 15, 2024, 113 days before the election and shall be filed with the Elections Division no later than 5:00 p.m., August 9, 2024, the 88th day before the election.

Current law requires all candidates to file a Statement of Economic Interest (Form 700) with the county elections division where they file their declaration of candidacy. These forms are due no later than the final filing date for the declaration of candidacy. The form can be found on the FPPC website (www.fppc.ca.gov) or is available at the Elections Division. To obtain information regarding filing, call the Elections Division (661) 868-3590 or visit our website for the Candidate Handbook at <http://www.kernvote.com>.

In the event there are no nominees or an insufficient number of nominees for each office and a petition for an election is not timely filed, an appointment to such office shall be made pursuant to Elections Code Section 10515.

Each candidate filing for a nonpartisan elective office may prepare a Candidate's Statement pursuant to Section 13307 of the Elections Code. Such statements may include the name, age, and occupation of the candidate and a brief description of no more than 200 words of the candidate's education and qualifications expressed by the candidate. Each statement shall be included in the Sample Ballot, which is mailed to each voter.

Each candidate filing a statement will be required to pay in advance their pro rata share as a condition of having their statement included in the Sample Ballot.
