## **RESOLUTION NO. 2024-05**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARICOPA, CALIFORNIA ORDERING THE SUBMISSION TO THE QUALIFIED ELECTORS OF THE CITY OF A CERTAIN MEASURE RELATING TO THE IMPOSITION OF AN ADDITIONAL TRANSACTIONS AND USE TAX ("SALES TAX") IN THE AMOUNT OF ONE PERCENT (1.00%) AT THE GENERAL ELECTION TO BE HELD ON TUESDAY NOVEMBER 5, 2024 AS CALLED BY RESOLUTION NO. 2024-03

WHEREAS, a general election on Tuesday, November 5, 2024 has been called by Resolution No. 2024-03 adopted on June 11, 2024; and

WHEREAS, the City Council of the City of Maricopa ("City Council") also desires to submit to the voters at the election a question relating to the imposition of an additional transaction and Use Tax ("Sales Tax") in the amount of one percent (1.00%); and

WHEREAS, under the provisions of California Revenue and Taxation Code Section 7285.9 and the laws relating to general law cities in the State of California, a general municipal election may be held on November 5, 2024, for the consideration of the imposition of a sales tax, the proceeds of which may be used for the general purposes of the City of Maricopa.

**NOW THEREFORE,** the City Council of the City of Maricopa does hereby resolve, declare, determine and order as follows:

Section 1. That the City Council, pursuant to its right and authority, does order submitted to the voters at the General Municipal election the following question:

City of Maricopa Transactions and Use Tax Ordinance for Essential General Fund Services.

Shall there be enacted in the City of Maricopa an additional YES temporary sales tax rate increase of one percent (1.00%) which will end after ten (10) years, the proceeds of which shall be used to preserve essential general governmental services including, but not limited to street and road NO improvements, police and fire protection, parks and recreation and other City General Fund services?

- Section 2. That the proposed measure, which will amend the City of Maricopa Municipal Code, submitted to the registered electors to be voted on is attached as Exhibit "A".
- Section 3. The City Attorney is directed to prepare an impartial analysis concerning the measure to be voted on.
- Section 4. The City Treasurer is directed to prepare an Impartial Fiscal Impact Statement to be included on the ballot concerning the measure to be voted on.

Section 5. That in all particulars not recited in this Resolution, the election shall be held and conducted as provided by law for holding municipal elections.

Section 6. That notice of the time and place of holding the election is given and the City Clerk is authorized, instructed and directed to give further or additional notice of the election, in time, form and manner as required by law.

Section 7. That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.
